



BEARFACTS 1993 – 2003

Portsmouth (Independent City) , Virginia [51740]

Portsmouth (Independent City) is one of 105 counties in Virginia. It is part of the [Virginia Beach-Norfolk-Newport News, VA-NC \(MSA\)](#). Its 2003 population of 99,507 ranked 23rd in the state.

PER CAPITA PERSONAL INCOME

In 2003 Portsmouth (Independent City) had a per capita personal income (PCPI) of \$25,616. This PCPI ranked 54th in the state and was 75 percent of the state average, \$34,001, and 81 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 5.8 percent from 2002. The 2002-2003 state change was 2.9 percent and the national change was 2.2 percent. In 1993 the PCPI of Portsmouth (Independent City) was \$16,819 and ranked 58th in the state. The 1993-2003 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Portsmouth (Independent City) had a total personal income (TPI) of \$2,548,957*. This TPI ranked 25th in the state and accounted for 1.0 percent of the state total. In 1993 the TPI of Portsmouth (Independent City) was \$1,764,982* and ranked 20th in the state. The 2003 TPI reflected an increase of 5.7 percent from 2002. The 2002-2003 state change was 4.2 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 3.7 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Portsmouth (Independent City). In 2003 net earnings accounted for 66.8 percent of TPI (compared with 64.9 in 1993); dividends, interest, and rent were 13.5 percent (compared with 16.7 in 1993); and personal current transfer receipts were 19.7 percent (compared with 18.3 in 1993). From 2002 to 2003 net earnings increased 6.9 percent; dividends, interest, and rent remained unchanged; and personal current transfer receipts increased 5.8 percent. From 1993 to 2003 net earnings increased on average 4.0 percent each year; dividends, interest, and rent increased on average 1.6 percent; and personal current transfer receipts increased on average 4.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Portsmouth (Independent City) increased from \$2,437,261* in 2002 to \$2,632,615* in 2003, an increase of 8.0 percent. The 2002-2003 state change was 4.5 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$1,820,345* to the 2003 estimate was 3.8 percent. The average annual growth rate for the state was 5.9 percent and for the nation was 5.3 percent.
