



BEARFACTS 1993 – 2003

Wirt , West Virginia [54105]

Wirt is one of 55 counties in West Virginia. It is part of the [Parkersburg-Marietta-Vienna, WV-OH \(MSA\)](#). Its 2003 population of 5,746 ranked 55th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Wirt had a per capita personal income (PCPI) of \$17,406. This PCPI ranked 50th in the state and was 72 percent of the state average, \$24,313, and 55 percent of the national average, \$31,504. The 2003 PCPI reflected a decrease of 0.7 percent from 2002. The 2002-2003 state change was 1.0 percent and the national change was 2.2 percent. In 1993 the PCPI of Wirt was \$12,179 and ranked 49th in the state. The 1993-2003 average annual growth rate of PCPI was 3.6 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Wirt had a total personal income (TPI) of \$100,014*. This TPI ranked 55th in the state and accounted for 0.2 percent of the state total. In 1993 the TPI of Wirt was \$65,254* and ranked 55th in the state. The 2003 TPI reflected a decrease of 1.6 percent from 2002. The 2002-2003 state change was 1.2 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 4.4 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Wirt. In 2003 net earnings accounted for 60.3 percent of TPI (compared with 62.4 in 1993); dividends, interest, and rent were 10.9 percent (compared with 11.4 in 1993); and personal current transfer receipts were 28.8 percent (compared with 26.2 in 1993). From 2002 to 2003 net earnings decreased 0.3 percent; dividends, interest, and rent decreased 14.2 percent; and personal current transfer receipts increased 1.2 percent. From 1993 to 2003 net earnings increased on average 4.0 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 5.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Wirt increased from \$25,092* in 2002 to \$26,203* in 2003, an increase of 4.4 percent. The 2002-2003 state change was 2.9 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$20,177* to the 2003 estimate was 2.6 percent. The average annual growth rate for the state was 3.6 percent and for the nation was 5.3 percent.
