



BEARFACTS 1994 – 2004

Muncie (MSA) [34620]

Muncie is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2004 population of 117,795 ranked 301st in the nation.

PER CAPITA PERSONAL INCOME

In 2004 Muncie had a per capita personal income (PCPI) of \$25,615. This PCPI ranked 304th in the United States and was 77 percent of the national average, \$33,123. The 2004 PCPI reflected a decrease of 1.3 percent from 2003. The 2003-2004 national change was 5.1 percent. In 1994 the PCPI of Muncie was \$19,052 and ranked 220th in the United States. The 1994-2004 average annual growth rate of PCPI was 3.0 percent. The average annual growth rate for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Muncie had a total personal income (TPI) of \$3,017,312*. This TPI ranked 308th in the United States. In 1994 the TPI of Muncie was \$2,296,071* and ranked 276th in the United States. The 2004 TPI reflected a decrease of 2.4 percent from 2003. The 2003-2004 national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 2.8 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Muncie. In 2004 net earnings accounted for 65.5 percent of TPI (compared with 67.0 in 1994); dividends, interest, and rent were 14.8 percent (compared with 16.6 in 1994); and personal current transfer receipts were 19.8 percent (compared with 16.4 in 1994). From 2003 to 2004 net earnings decreased 2.0 percent; dividends, interest, and rent decreased 11.4 percent; and personal current transfer receipts increased 4.6 percent. From 1994 to 2004 net earnings increased on average 2.5 percent each year; dividends, interest, and rent increased on average 1.6 percent; and personal current transfer receipts increased on average 4.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Muncie decreased from \$2,267,892* in 2003 to \$2,181,450* in 2004, a decrease of 3.8 percent. The 2003-2004 national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$1,809,537* to the 2004 estimate was 1.9 percent. The average annual growth rate for the nation was 5.5 percent.
