



BEARFACTS 1994 – 2004

Guadalupe , New Mexico [35019]

Guadalupe is one of 33 counties in New Mexico. It is not part of a Metropolitan Area. Its 2004 population of 4,525 ranked 29th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Guadalupe had a per capita personal income (PCPI) of \$15,128. This PCPI ranked 33rd in the state and was 57 percent of the state average, \$26,326, and 46 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 11.0 percent from 2003. The 2003-2004 state change was 5.5 percent and the national change was 5.1 percent. In 1994 the PCPI of Guadalupe was \$12,380 and ranked 29th in the state. The 1994-2004 average annual growth rate of PCPI was 2.0 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Guadalupe had a total personal income (TPI) of \$68,456*. This TPI ranked 30th in the state and accounted for 0.1 percent of the state total. In 1994 the TPI of Guadalupe was \$52,180* and ranked 29th in the state. The 2004 TPI reflected an increase of 6.8 percent from 2003. The 2003-2004 state change was 6.8 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 2.8 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Guadalupe. In 2004 net earnings accounted for 47.0 percent of TPI (compared with 56.8 in 1994); dividends, interest, and rent were 10.5 percent (compared with 14.8 in 1994); and personal current transfer receipts were 42.5 percent (compared with 28.4 in 1994). From 2003 to 2004 net earnings increased 11.1 percent; dividends, interest, and rent decreased 8.7 percent; and personal current transfer receipts increased 6.6 percent. From 1994 to 2004 net earnings increased on average 0.8 percent each year; dividends, interest, and rent decreased on average 0.7 percent; and personal current transfer receipts increased on average 7.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Guadalupe increased from \$36,094* in 2003 to \$41,736* in 2004, an increase of 15.6 percent. The 2003-2004 state change was 7.0 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$37,644* to the 2004 estimate was 1.0 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.5 percent.
