



BEARFACTS 1994 – 2004

Currituck , North Carolina [37053]

Currituck is one of 100 counties in North Carolina. It is part of the [Virginia Beach-Norfolk-Newport News, VA-NC \(MSA\)](#). Its 2004 population of 21,816 ranked 78th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Currituck had a per capita personal income (PCPI) of \$28,733. This PCPI ranked 18th in the state and was 98 percent of the state average, \$29,440, and 87 percent of the national average, \$33,157. The 2004 PCPI reflected an increase of 4.2 percent from 2003. The 2003-2004 state change was 5.4 percent and the national change was 5.2 percent. In 1994 the PCPI of Currituck was \$18,521 and ranked 35th in the state. The 1994-2004 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the state was 3.7 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Currituck had a total personal income (TPI) of \$626,832*. This TPI ranked 73rd in the state and accounted for 0.2 percent of the state total. In 1994 the TPI of Currituck was \$289,928* and ranked 81st in the state. The 2004 TPI reflected an increase of 10.5 percent from 2003. The 2003-2004 state change was 6.8 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 8.0 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Currituck. In 2004 net earnings accounted for 73.0 percent of TPI (compared with 70.6 in 1994); dividends, interest, and rent were 12.9 percent (compared with 15.4 in 1994); and personal current transfer receipts were 14.1 percent (compared with 14.0 in 1994). From 2003 to 2004 net earnings increased 9.5 percent; dividends, interest, and rent increased 14.5 percent; and personal current transfer receipts increased 12.4 percent. From 1994 to 2004 net earnings increased on average 8.4 percent each year; dividends, interest, and rent increased on average 6.1 percent; and personal current transfer receipts increased on average 8.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Currituck increased from \$185,780* in 2003 to \$198,234* in 2004, an increase of 6.7 percent. The 2003-2004 state change was 6.1 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$78,136* to the 2004 estimate was 9.8 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.5 percent.
