



BEARFACTS 1994 – 2004

Throckmorton , Texas [48447]

Throckmorton is one of 254 counties in Texas. It is not part of a Metropolitan Area. Its 2004 population of 1,641 ranked 241st in the state.

PER CAPITA PERSONAL INCOME

In 2004 Throckmorton had a per capita personal income (PCPI) of \$28,789. This PCPI ranked 45th in the state and was 93 percent of the state average, \$30,948, and 87 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 2.7 percent from 2003. The 2003-2004 state change was 5.3 percent and the national change was 5.1 percent. In 1994 the PCPI of Throckmorton was \$18,295 and ranked 73rd in the state. The 1994-2004 average annual growth rate of PCPI was 4.6 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Throckmorton had a total personal income (TPI) of \$47,242*. This TPI ranked 234th in the state and accounted for 0.0 percent of the state total. In 1994 the TPI of Throckmorton was \$34,888* and ranked 235th in the state. The 2004 TPI reflected a decrease of 0.7 percent from 2003. The 2003-2004 state change was 7.0 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 3.1 percent. The average annual growth rate for the state was 6.4 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Throckmorton. In 2004 net earnings accounted for 58.8 percent of TPI (compared with 53.3 in 1994); dividends, interest, and rent were 18.9 percent (compared with 26.9 in 1994); and personal current transfer receipts were 22.3 percent (compared with 19.9 in 1994). From 2003 to 2004 net earnings increased 8.8 percent; dividends, interest, and rent decreased 25.2 percent; and personal current transfer receipts increased 4.2 percent. From 1994 to 2004 net earnings increased on average 4.1 percent each year; dividends, interest, and rent decreased on average 0.5 percent; and personal current transfer receipts increased on average 4.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Throckmorton increased from \$21,516* in 2003 to \$23,351* in 2004, an increase of 8.5 percent. The 2003-2004 state change was 7.9 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$17,253* to the 2004 estimate was 3.1 percent. The average annual growth rate for the state was 6.8 percent and for the nation was 5.5 percent.
