



BEARFACTS 1995 – 2005

Fairbanks North Star Borough , Alaska [02090]

Fairbanks North Star Borough is one of 27 counties in Alaska. It is part of the [Fairbanks, AK \(MSA\)](#). Its 2005 population of 94,514 ranked 2nd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Fairbanks North Star Borough had a per capita personal income (PCPI) of \$32,001. This PCPI ranked 16th in the state and was 88 percent of the state average, \$36,261, and 92 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 8.1 percent from 2004. The 2004-2005 state change was 6.9 percent and the national change was 4.9 percent. In 1995 the PCPI of Fairbanks North Star Borough was \$22,921 and ranked 14th in the state. The 1995-2005 average annual growth rate of PCPI was 3.4 percent. The average annual growth rate for the state was 3.6 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Fairbanks North Star Borough had a total personal income (TPI) of \$3,024,557*. This TPI ranked 2nd in the state and accounted for 12.5 percent of the state total. In 1995 the TPI of Fairbanks North Star Borough was \$1,878,174* and ranked 2nd in the state. The 2005 TPI reflected an increase of 10.6 percent from 2004. The 2004-2005 state change was 8.2 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 4.9 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Fairbanks North Star Borough. In 2005 net earnings accounted for 70.9 percent of TPI (compared with 68.7 in 1995); dividends, interest, and rent were 14.8 percent (compared with 18.1 in 1995); and personal current transfer receipts were 14.3 percent (compared with 13.2 in 1995). From 2004 to 2005 net earnings increased 9.4 percent; dividends, interest, and rent increased 17.8 percent; and personal current transfer receipts increased 9.5 percent. From 1995 to 2005 net earnings increased on average 5.2 percent each year; dividends, interest, and rent increased on average 2.8 percent; and personal current transfer receipts increased on average 5.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Fairbanks North Star Borough increased from \$2,489,397* in 2004 to \$2,721,745* in 2005, an increase of 9.3 percent. The 2004-2005 state change was 6.5 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$1,600,137* to the 2005 estimate was 5.5 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.5 percent.
