



BEARFACTS 1995 – 2005

Okaloosa , Florida [12091]

Okaloosa is one of 67 counties in Florida. It is part of the [Fort Walton Beach-Crestview-Destin, FL \(MSA\)](#). Its 2005 population of 183,438 ranked 24th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Okaloosa had a per capita personal income (PCPI) of \$35,023. This PCPI ranked 14th in the state and was 101 percent of the state average, \$34,798, and 101 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 6.5 percent from 2004. The 2004-2005 state change was 6.7 percent and the national change was 4.9 percent. In 1995 the PCPI of Okaloosa was \$20,141 and ranked 22nd in the state. The 1995-2005 average annual growth rate of PCPI was 5.7 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Okaloosa had a total personal income (TPI) of \$6,424,629*. This TPI ranked 24th in the state and accounted for 1.0 percent of the state total. In 1995 the TPI of Okaloosa was \$3,280,913* and ranked 23rd in the state. The 2005 TPI reflected an increase of 7.2 percent from 2004. The 2004-2005 state change was 9.1 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 7.0 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Okaloosa. In 2005 net earnings accounted for 65.9 percent of TPI (compared with 66.0 in 1995); dividends, interest, and rent were 20.3 percent (compared with 20.7 in 1995); and personal current transfer receipts were 13.8 percent (compared with 13.3 in 1995). From 2004 to 2005 net earnings increased 7.0 percent; dividends, interest, and rent increased 13.3 percent; and personal current transfer receipts decreased 0.1 percent. From 1995 to 2005 net earnings increased on average 6.9 percent each year; dividends, interest, and rent increased on average 6.8 percent; and personal current transfer receipts increased on average 7.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Okaloosa increased from \$4,997,449* in 2004 to \$5,380,446* in 2005, an increase of 7.7 percent. The 2004-2005 state change was 8.8 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$2,611,848* to the 2005 estimate was 7.5 percent. The average annual growth rate for the state was 6.7 percent and for the nation was 5.5 percent.
