



BEARFACTS 1995 – 2005

Bronx , New York [36005]

Bronx is one of 62 counties in New York. It is part of the [New York-Northern New Jersey-Long Island, NY-NJ-PA \(MSA\)](#). Its 2005 population of 1,364,566 ranked 5th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Bronx had a per capita personal income (PCPI) of \$23,435. This PCPI ranked 59th in the state and was 57 percent of the state average, \$41,016, and 67 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 2.7 percent from 2004. The 2004-2005 state change was 6.7 percent and the national change was 4.9 percent. In 1995 the PCPI of Bronx was \$16,602 and ranked 54th in the state. The 1995-2005 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Bronx had a total personal income (TPI) of \$31,978,506*. This TPI ranked 7th in the state and accounted for 4.0 percent of the state total. In 1995 the TPI of Bronx was \$20,952,819* and ranked 8th in the state. The 2005 TPI reflected an increase of 2.0 percent from 2004. The 2004-2005 state change was 6.8 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 4.3 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Bronx. In 2005 net earnings accounted for 59.0 percent of TPI (compared with 54.4 in 1995); dividends, interest, and rent were 7.2 percent (compared with 11.8 in 1995); and personal current transfer receipts were 33.9 percent (compared with 33.8 in 1995). From 2004 to 2005 net earnings increased 6.2 percent; dividends, interest, and rent decreased 5.2 percent; and personal current transfer receipts decreased 3.1 percent. From 1995 to 2005 net earnings increased on average 5.2 percent each year; dividends, interest, and rent decreased on average 0.8 percent; and personal current transfer receipts increased on average 4.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Bronx increased from \$12,285,406* in 2004 to \$12,932,164* in 2005, an increase of 5.3 percent. The 2004-2005 state change was 5.4 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$8,476,038* to the 2005 estimate was 4.3 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.5 percent.
