



BEARFACTS 1995 – 2005

Adams , North Dakota [38001]

Adams is one of 53 counties in North Dakota. It is not part of a Metropolitan Area. Its 2005 population of 2,356 ranked 44th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Adams had a per capita personal income (PCPI) of \$27,979. This PCPI ranked 41st in the state and was 88 percent of the state average, \$31,871, and 80 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 17.4 percent from 2004. The 2004-2005 state change was 8.9 percent and the national change was 4.9 percent. In 1995 the PCPI of Adams was \$16,413 and ranked 33rd in the state. The 1995-2005 average annual growth rate of PCPI was 5.5 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Adams had a total personal income (TPI) of \$65,919*. This TPI ranked 45th in the state and accounted for 0.3 percent of the state total. In 1995 the TPI of Adams was \$46,187* and ranked 42nd in the state. The 2005 TPI reflected an increase of 15.4 percent from 2004. The 2004-2005 state change was 8.7 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 3.6 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Adams. In 2005 net earnings accounted for 54.9 percent of TPI (compared with 48.7 in 1995); dividends, interest, and rent were 19.3 percent (compared with 26.7 in 1995); and personal current transfer receipts were 25.9 percent (compared with 24.5 in 1995). From 2004 to 2005 net earnings increased 22.8 percent; dividends, interest, and rent increased 11.1 percent; and personal current transfer receipts increased 5.2 percent. From 1995 to 2005 net earnings increased on average 4.9 percent each year; dividends, interest, and rent increased on average 0.3 percent; and personal current transfer receipts increased on average 4.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Adams increased from \$33,452* in 2004 to \$40,349* in 2005, an increase of 20.6 percent. The 2004-2005 state change was 8.3 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$26,661* to the 2005 estimate was 4.2 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.5 percent.
