



BEARFACTS 1995 – 2005

Walsh , North Dakota [38099]

Walsh is one of 53 counties in North Dakota. It is not part of a Metropolitan Area. Its 2005 population of 11,398 ranked 11th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Walsh had a per capita personal income (PCPI) of \$29,637. This PCPI ranked 32nd in the state and was 93 percent of the state average, \$31,871, and 85 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 11.7 percent from 2004. The 2004-2005 state change was 8.9 percent and the national change was 4.9 percent. In 1995 the PCPI of Walsh was \$19,069 and ranked 9th in the state. The 1995-2005 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Walsh had a total personal income (TPI) of \$337,799*. This TPI ranked 12th in the state and accounted for 1.7 percent of the state total. In 1995 the TPI of Walsh was \$254,876* and ranked 10th in the state. The 2005 TPI reflected an increase of 10.7 percent from 2004. The 2004-2005 state change was 8.7 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 2.9 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Walsh. In 2005 net earnings accounted for 62.7 percent of TPI (compared with 60.5 in 1995); dividends, interest, and rent were 17.0 percent (compared with 20.9 in 1995); and personal current transfer receipts were 20.3 percent (compared with 18.6 in 1995). From 2004 to 2005 net earnings increased 12.8 percent; dividends, interest, and rent increased 11.6 percent; and personal current transfer receipts increased 4.0 percent. From 1995 to 2005 net earnings increased on average 3.2 percent each year; dividends, interest, and rent increased on average 0.8 percent; and personal current transfer receipts increased on average 3.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Walsh increased from \$208,423* in 2004 to \$233,788* in 2005, an increase of 12.2 percent. The 2004-2005 state change was 8.3 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$174,262* to the 2005 estimate was 3.0 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.5 percent.
