



BEARFACTS 1995 – 2005

Northumberland , Pennsylvania [42097]

Northumberland is one of 67 counties in Pennsylvania. It is part of the Sunbury, PA Micropolitan SA. Its 2005 population of 91,534 ranked 33rd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Northumberland had a per capita personal income (PCPI) of \$26,300. This PCPI ranked 47th in the state and was 76 percent of the state average, \$34,774, and 76 percent of the national average, \$34,690. The 2005 PCPI reflected an increase of 0.6 percent from 2004. The 2004-2005 state change was 3.6 percent and the national change was 4.6 percent. In 1995 the PCPI of Northumberland was \$18,232 and ranked 47th in the state. The 1995-2005 average annual growth rate of PCPI was 3.7 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Northumberland had a total personal income (TPI) of \$2,407,340*. This TPI ranked 32nd in the state and accounted for 0.6 percent of the state total. In 1995 the TPI of Northumberland was \$1,768,659* and ranked 32nd in the state. The 2005 TPI remained unchanged from 2004. The 2004-2005 state change was 3.8 percent and the national change was 5.6 percent. The 1995-2005 average annual growth rate of TPI was 3.1 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Northumberland. In 2005 net earnings accounted for 62.2 percent of TPI (compared with 60.1 in 1995); dividends, interest, and rent were 12.4 percent (compared with 17.3 in 1995); and personal current transfer receipts were 25.4 percent (compared with 22.6 in 1995). From 2004 to 2005 net earnings increased 3.9 percent; dividends, interest, and rent decreased 22.0 percent; and personal current transfer receipts increased 5.1 percent. From 1995 to 2005 net earnings increased on average 3.5 percent each year; dividends, interest, and rent decreased on average 0.2 percent; and personal current transfer receipts increased on average 4.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Northumberland increased from \$1,296,081* in 2004 to \$1,338,876* in 2005, an increase of 3.3 percent. The 2004-2005 state change was 4.2 percent and the national change was 5.3 percent. The average annual growth rate from the 1995 estimate of \$991,265* to the 2005 estimate was 3.1 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.5 percent.
