



BEARFACTS 1996 – 2006

Monona , Iowa [19133]

Monona is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2006 population of 9,181 ranked 83rd in the state.

PER CAPITA PERSONAL INCOME

In 2006 Monona had a per capita personal income (PCPI) of \$25,925. This PCPI ranked 90th in the state and was 79 percent of the state average, \$32,741, and 70 percent of the national average, \$36,794. The 2006 PCPI reflected a decrease of 1.4 percent from 2005. The 2005-2006 state change was 3.7 percent and the national change was 6.1 percent. In 1996 the PCPI of Monona was \$20,661 and ranked 70th in the state. The 1996-2006 average annual growth rate of PCPI was 2.3 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Monona had a total personal income (TPI) of \$238,018*. This TPI ranked 84th in the state and accounted for 0.2 percent of the state total. In 1996 the TPI of Monona was \$208,038* and ranked 82nd in the state. The 2006 TPI reflected a decrease of 3.1 percent from 2005. The 2005-2006 state change was 4.2 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 1.4 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Monona. In 2006 net earnings accounted for 56.7 percent of TPI (compared with 58.8 in 1996); dividends, interest, and rent were 13.9 percent (compared with 19.8 in 1996); and personal current transfer receipts were 29.4 percent (compared with 21.4 in 1996). From 2005 to 2006 net earnings decreased 8.4 percent; dividends, interest, and rent decreased 4.9 percent; and personal current transfer receipts increased 10.0 percent. From 1996 to 2006 net earnings increased on average 1.0 percent each year; dividends, interest, and rent decreased on average 2.2 percent; and personal current transfer receipts increased on average 4.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Monona decreased from \$131,687* in 2005 to \$117,642* in 2006, a decrease of 10.7 percent. The 2005-2006 state change was 3.6 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$116,454* to the 2006 estimate was 0.1 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.5 percent.
