



BEARFACTS 1996 – 2006 Sedgwick , Kansas [20173]

Sedgwick is one of 105 counties in Kansas. It is part of the [Wichita, KS \(MSA\)](#). Its 2006 population of 468,235 ranked 2nd in the state.

PER CAPITA PERSONAL INCOME

In 2006 Sedgwick had a per capita personal income (PCPI) of \$38,318. This PCPI ranked 2nd in the state and was 111 percent of the state average, \$34,525, and 104 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 10.4 percent from 2005. The 2005-2006 state change was 7.5 percent and the national change was 6.1 percent. In 1996 the PCPI of Sedgwick was \$24,378 and ranked 6th in the state. The 1996-2006 average annual growth rate of PCPI was 4.6 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Sedgwick had a total personal income (TPI) of \$17,941,720*. This TPI ranked 2nd in the state and accounted for 18.9 percent of the state total. In 1996 the TPI of Sedgwick was \$10,550,073* and ranked 2nd in the state. The 2006 TPI reflected an increase of 11.3 percent from 2005. The 2005-2006 state change was 8.0 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 5.5 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Sedgwick. In 2006 net earnings accounted for 70.9 percent of TPI (compared with 69.0 in 1996); dividends, interest, and rent were 16.1 percent (compared with 18.8 in 1996); and personal current transfer receipts were 12.9 percent (compared with 12.2 in 1996). From 2005 to 2006 net earnings increased 10.9 percent; dividends, interest, and rent increased 16.3 percent; and personal current transfer receipts increased 7.6 percent. From 1996 to 2006 net earnings increased on average 5.7 percent each year; dividends, interest, and rent increased on average 3.8 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Sedgwick increased from \$14,253,321* in 2005 to \$15,828,257* in 2006, an increase of 11.0 percent. The 2005-2006 state change was 6.3 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$9,209,478* to the 2006 estimate was 5.6 percent. The average annual growth rate for the state was 5.1 percent and for the nation was 5.5 percent.
