



BEARFACTS 1996 – 2006

Tensas , Louisiana [22107]

Tensas is one of 64 counties in Louisiana. It is not part of a Metropolitan Area. Its 2006 population of 5,999 ranked 64th in the state.

PER CAPITA PERSONAL INCOME

In 2006 Tensas had a per capita personal income (PCPI) of \$25,582. This PCPI ranked 34th in the state and was 78 percent of the state average, \$32,832, and 70 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 3.2 percent from 2005. The 2005-2006 state change was 33.2 percent and the national change was 6.1 percent. In 1996 the PCPI of Tensas was \$17,862 and ranked 18th in the state. The 1996-2006 average annual growth rate of PCPI was 3.7 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Tensas had a total personal income (TPI) of \$153,465*. This TPI ranked 64th in the state and accounted for 0.1 percent of the state total. In 1996 the TPI of Tensas was \$123,316* and ranked 64th in the state. The 2006 TPI reflected an increase of 4.1 percent from 2005. The 2005-2006 state change was 25.7 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 2.2 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Tensas. In 2006 net earnings accounted for 48.2 percent of TPI (compared with 59.7 in 1996); dividends, interest, and rent were 23.6 percent (compared with 13.7 in 1996); and personal current transfer receipts were 28.3 percent (compared with 26.6 in 1996). From 2005 to 2006 net earnings increased 11.8 percent; dividends, interest, and rent decreased 6.5 percent; and personal current transfer receipts increased 1.7 percent. From 1996 to 2006 net earnings remained unchanged; dividends, interest, and rent increased on average 7.9 percent; and personal current transfer receipts increased on average 2.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Tensas increased from \$64,982* in 2005 to \$73,437* in 2006, an increase of 13.0 percent. The 2005-2006 state change was 13.0 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$73,808* to the 2006 estimate was - 0.1 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.5 percent.
