



BEARFACTS 1996 – 2006

Lawton (MSA) [30020]

Lawton is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2006 population of 112,256 ranked 320th in the nation.

PER CAPITA PERSONAL INCOME

In 2006 Lawton had a per capita personal income (PCPI) of \$30,695. This PCPI ranked 213th in the United States and was 83 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 10.2 percent from 2005. The 2005-2006 national change was 6.1 percent. In 1996 the PCPI of Lawton was \$18,064 and ranked 333rd in the United States. The 1996-2006 average annual growth rate of PCPI was 5.4 percent. The average annual growth rate for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Lawton had a total personal income (TPI) of \$3,445,697*. This TPI ranked 303rd in the United States. In 1996 the TPI of Lawton was \$2,106,905* and ranked 307th in the United States. The 2006 TPI reflected an increase of 10.6 percent from 2005. The 2005-2006 national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 5.0 percent. The average annual growth rate for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Lawton. In 2006 net earnings accounted for 72.6 percent of TPI (compared with 71.2 in 1996); dividends, interest, and rent were 10.7 percent (compared with 14.5 in 1996); and personal current transfer receipts were 16.8 percent (compared with 14.2 in 1996). From 2005 to 2006 net earnings increased 11.8 percent; dividends, interest, and rent increased 7.8 percent; and personal current transfer receipts increased 7.6 percent. From 1996 to 2006 net earnings increased on average 5.2 percent each year; dividends, interest, and rent increased on average 1.9 percent; and personal current transfer receipts increased on average 6.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Lawton increased from \$2,564,704* in 2005 to \$2,864,372* in 2006, an increase of 11.7 percent. The 2005-2006 national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$1,734,851* to the 2006 estimate was 5.1 percent. The average annual growth rate for the nation was 5.5 percent.
