



BEARFACTS 1996 – 2006

Hall , Texas [48191]

Hall is one of 254 counties in Texas. It is not part of a Metropolitan Area. Its 2006 population of 3,606 ranked 215th in the state.

PER CAPITA PERSONAL INCOME

In 2006 Hall had a per capita personal income (PCPI) of \$18,370. This PCPI ranked 243rd in the state and was 52 percent of the state average, \$35,162, and 50 percent of the national average, \$36,794. The 2006 PCPI reflected a decrease of 10.1 percent from 2005. The 2005-2006 state change was 5.8 percent and the national change was 6.1 percent. In 1996 the PCPI of Hall was \$15,408 and ranked 192nd in the state. The 1996-2006 average annual growth rate of PCPI was 1.8 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Hall had a total personal income (TPI) of \$66,244*. This TPI ranked 227th in the state and accounted for 0.0 percent of the state total. In 1996 the TPI of Hall was \$59,782* and ranked 221st in the state. The 2006 TPI reflected a decrease of 10.4 percent from 2005. The 2005-2006 state change was 8.3 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 1.0 percent. The average annual growth rate for the state was 6.7 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hall. In 2006 net earnings accounted for 47.1 percent of TPI (compared with 46.3 in 1996); dividends, interest, and rent were 13.5 percent (compared with 21.5 in 1996); and personal current transfer receipts were 39.4 percent (compared with 32.1 in 1996). From 2005 to 2006 net earnings decreased 17.8 percent; dividends, interest, and rent decreased 15.8 percent; and personal current transfer receipts increased 2.8 percent. From 1996 to 2006 net earnings increased on average 1.2 percent each year; dividends, interest, and rent decreased on average 3.6 percent; and personal current transfer receipts increased on average 3.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hall decreased from \$46,529* in 2005 to \$38,806* in 2006, a decrease of 16.6 percent. The 2005-2006 state change was 8.7 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$34,123* to the 2006 estimate was 1.3 percent. The average annual growth rate for the state was 7.1 percent and for the nation was 5.5 percent.
