



BEARFACTS 1997 – 2007

Denali Borough , Alaska [02068]

Denali Borough is one of 27 counties in Alaska. It is not part of a Metropolitan Area. Its 2007 population of 1,831 ranked 24th in the state.

PER CAPITA PERSONAL INCOME

In 2007 Denali Borough had a per capita personal income (PCPI) of \$50,465. This PCPI ranked 2nd in the state and was 126 percent of the state average, \$40,042, and 131 percent of the national average, \$38,615. The 2007 PCPI reflected an increase of 2.8 percent from 2006. The 2006-2007 state change was 4.4 percent and the national change was 4.9 percent. In 1997 the PCPI of Denali Borough was \$28,238 and ranked 5th in the state. The 1997-2007 average annual growth rate of PCPI was 6.0 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2007 Denali Borough had a total personal income (TPI) of \$92,402*. This TPI ranked 23rd in the state and accounted for 0.3 percent of the state total. In 1997 the TPI of Denali Borough was \$56,844* and ranked 23rd in the state. The 2007 TPI reflected an increase of 1.8 percent from 2006. The 2006-2007 state change was 5.2 percent and the national change was 6.0 percent. The 1997-2007 average annual growth rate of TPI was 5.0 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Denali Borough. In 2007 net earnings accounted for 69.5 percent of TPI (compared with 59.2 in 1997); dividends, interest, and rent were 8.2 percent (compared with 20.1 in 1997); and personal current transfer receipts were 22.3 percent (compared with 20.7 in 1997). From 2006 to 2007 net earnings increased 0.5 percent; dividends, interest, and rent decreased 0.7 percent; and personal current transfer receipts increased 6.7 percent. From 1997 to 2007 net earnings increased on average 6.7 percent each year; dividends, interest, and rent decreased on average 4.1 percent; and personal current transfer receipts increased on average 5.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Denali Borough increased from \$113,246* in 2006 to \$120,602* in 2007, an increase of 6.5 percent. The 2006-2007 state change was 4.5 percent and the national change was 4.9 percent. The average annual growth rate from the 1997 estimate of \$66,616* to the 2007 estimate was 6.1 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.4 percent.
