



BEARFACTS 1997 – 2007

Lee , Illinois [17103]

Lee is one of 102 counties in Illinois. It is part of the Dixon, IL Micropolitan SA. Its 2007 population of 35,089 ranked 42nd in the state.

PER CAPITA PERSONAL INCOME

In 2007 Lee had a per capita personal income (PCPI) of \$30,115. This PCPI ranked 49th in the state and was 73 percent of the state average, \$41,012, and 78 percent of the national average, \$38,615. The 2007 PCPI reflected an increase of 9.3 percent from 2006. The 2006-2007 state change was 6.6 percent and the national change was 4.9 percent. In 1997 the PCPI of Lee was \$21,169 and ranked 56th in the state. The 1997-2007 average annual growth rate of PCPI was 3.6 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2007 Lee had a total personal income (TPI) of \$1,056,688*. This TPI ranked 42nd in the state and accounted for 0.2 percent of the state total. In 1997 the TPI of Lee was \$766,781* and ranked 41st in the state. The 2007 TPI reflected an increase of 9.8 percent from 2006. The 2006-2007 state change was 7.2 percent and the national change was 6.0 percent. The 1997-2007 average annual growth rate of TPI was 3.3 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Lee. In 2007 net earnings accounted for 64.2 percent of TPI (compared with 61.2 in 1997); dividends, interest, and rent were 15.1 percent (compared with 23.0 in 1997); and personal current transfer receipts were 20.7 percent (compared with 15.8 in 1997). From 2006 to 2007 net earnings increased 9.2 percent; dividends, interest, and rent increased 6.8 percent; and personal current transfer receipts increased 14.3 percent. From 1997 to 2007 net earnings increased on average 3.7 percent each year; dividends, interest, and rent decreased on average 1.0 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Lee increased from \$624,287* in 2006 to \$672,680* in 2007, an increase of 7.8 percent. The 2006-2007 state change was 4.8 percent and the national change was 4.9 percent. The average annual growth rate from the 1997 estimate of \$473,835* to the 2007 estimate was 3.6 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.4 percent.
