



BEARFACTS 1997 – 2007

Hooker , Nebraska [31091]

Hooker is one of 93 counties in Nebraska. It is not part of a Metropolitan Area. Its 2007 population of 729 ranked 87th in the state.

PER CAPITA PERSONAL INCOME

In 2007 Hooker had a per capita personal income (PCPI) of \$18,294. This PCPI ranked 90th in the state and was 50 percent of the state average, \$36,372, and 47 percent of the national average, \$38,615. The 2007 PCPI reflected a decrease of 5.0 percent from 2006. The 2006-2007 state change was 6.8 percent and the national change was 4.9 percent. In 1997 the PCPI of Hooker was \$13,390 and ranked 86th in the state. The 1997-2007 average annual growth rate of PCPI was 3.2 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2007 Hooker had a total personal income (TPI) of \$13,336*. This TPI ranked 87th in the state and accounted for 0.0 percent of the state total. In 1997 the TPI of Hooker was \$10,270* and ranked 87th in the state. The 2007 TPI reflected a decrease of 6.9 percent from 2006. The 2006-2007 state change was 7.4 percent and the national change was 6.0 percent. The 1997-2007 average annual growth rate of TPI was 2.6 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hooker. In 2007 net earnings accounted for 29.5 percent of TPI (compared with 14.9 in 1997); dividends, interest, and rent were 29.3 percent (compared with 50.3 in 1997); and personal current transfer receipts were 41.2 percent (compared with 34.8 in 1997). From 2006 to 2007 net earnings decreased 28.0 percent; dividends, interest, and rent increased 5.9 percent; and personal current transfer receipts increased 6.2 percent. From 1997 to 2007 net earnings increased on average 9.9 percent each year; dividends, interest, and rent decreased on average 2.8 percent; and personal current transfer receipts increased on average 4.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hooker decreased from \$6,872* in 2006 to \$4,972* in 2007, a decrease of 27.6 percent. The 2006-2007 state change was 6.8 percent and the national change was 4.9 percent. The average annual growth rate from the 1997 estimate of \$2,838* to the 2007 estimate was 5.8 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.4 percent.
