



BEARFACTS 1997 – 2007

Cape Girardeau-Jackson (BEA-EA) [57025]

Cape Girardeau-Jackson is one of 179 BEA Economic Areas in the nation. Its 2007 population of 293,264 ranked 150th in the nation.

PER CAPITA PERSONAL INCOME

In 2007 Cape Girardeau-Jackson had a per capita personal income (PCPI) of \$27,064. This PCPI ranked 171st in the United States and was 70 percent of the national average, \$38,615. The 2007 PCPI reflected an increase of 4.9 percent from 2006. The 2006-2007 national change was 4.9 percent. In 1997 the PCPI of Cape Girardeau-Jackson was \$18,383 and ranked 170th in the United States. The 1997-2007 average annual growth rate of PCPI was 3.9 percent. The average annual growth rate for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2007 Cape Girardeau-Jackson had a total personal income (TPI) of \$7,936,798*. This TPI ranked 154th in the United States. In 1997 the TPI of Cape Girardeau-Jackson was \$5,348,403* and ranked 150th in the United States. The 2007 TPI reflected an increase of 4.9 percent from 2006. The 2006-2007 national change was 6.0 percent. The 1997-2007 average annual growth rate of TPI was 4.0 percent. The average annual growth rate for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Cape Girardeau-Jackson. In 2007 net earnings accounted for 59.2 percent of TPI (compared with 59.1 in 1997); dividends, interest, and rent were 12.9 percent (compared with 17.6 in 1997); and personal current transfer receipts were 27.9 percent (compared with 23.3 in 1997). From 2006 to 2007 net earnings increased 4.2 percent; dividends, interest, and rent increased 5.2 percent; and personal current transfer receipts increased 6.2 percent. From 1997 to 2007 net earnings increased on average 4.0 percent each year; dividends, interest, and rent increased on average 0.8 percent; and personal current transfer receipts increased on average 5.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Cape Girardeau-Jackson increased from \$5,117,820* in 2006 to \$5,326,377* in 2007, an increase of 4.1 percent. The 2006-2007 national change was 4.9 percent. The average annual growth rate from the 1997 estimate of \$3,536,110* to the 2007 estimate was 4.2 percent. The average annual growth rate for the nation was 5.4 percent.
