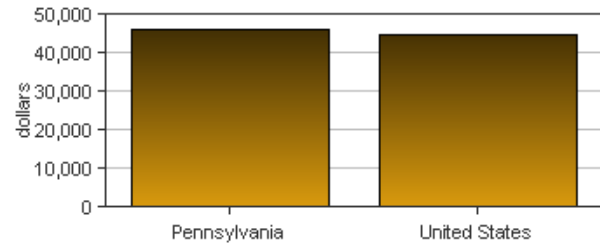

The population of Pennsylvania in 2013 was 12,773,801. Its rank was 6th in the nation.

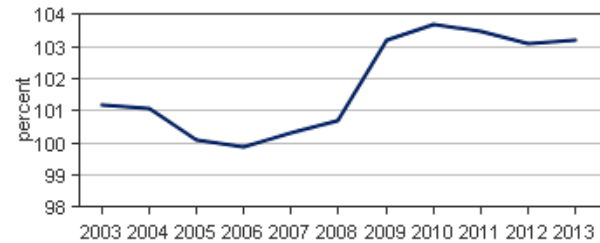
Per Capita Personal Income

In 2013, Pennsylvania had a per capita personal income (PCPI) of \$46,202. This PCPI ranked 18th in the United States and was 103 percent of the national average, \$44,765. The 2013 PCPI reflected an increase of 1.4 percent from 2012. The 2012-2013 national change was 1.3 percent. In 2003, the PCPI of Pennsylvania was \$33,074 and ranked 18th in the United States. The 2003-2013 compound annual growth rate of PCPI was 3.4 percent. The compound annual growth rate for the nation was 3.2 percent.

Total Personal Income

In 2013, Pennsylvania had a total personal income (TPI) of \$590,170,522*. This TPI ranked 6th in the United States. In 2003, the TPI of Pennsylvania was \$409,285,381* and ranked 6th in the United States.

Components of Total Personal Income

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Pennsylvania.

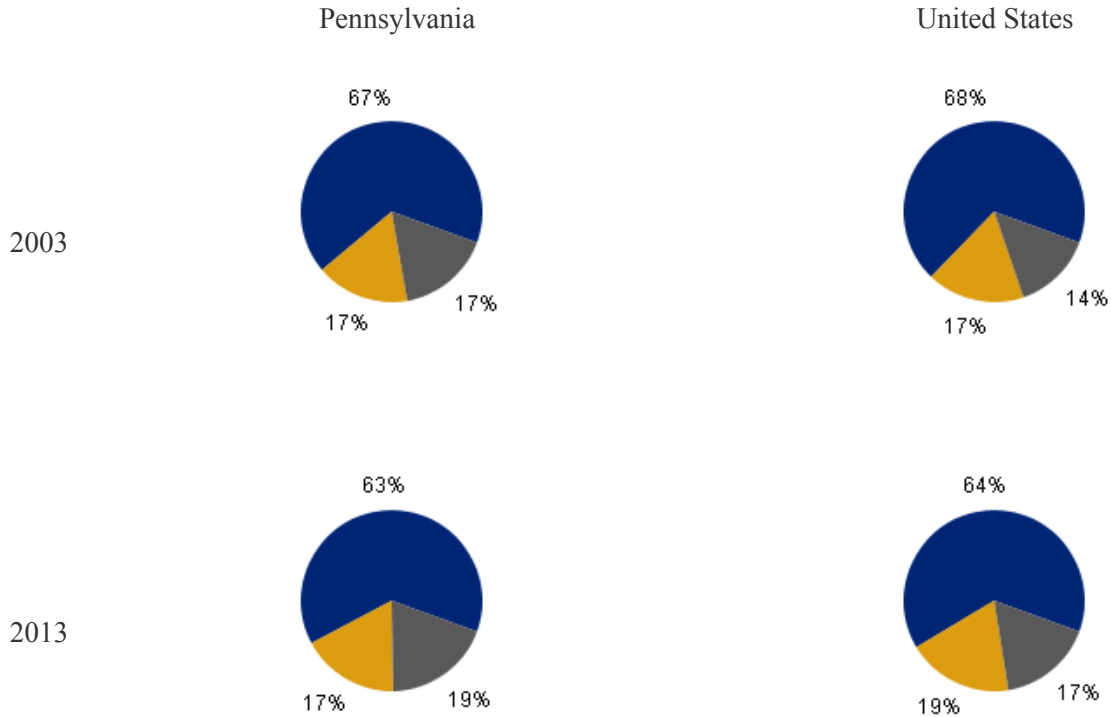

Gross Domestic Product (GDP) by State

In 2013, Pennsylvania current-dollar GDP was \$644.9 billion and ranked 6th in the United States. In 2003, Pennsylvania GDP was \$459.6 billion and ranked 6th in the United States.

In 2013, Pennsylvania real GDP grew 0.7 percent; the 2012-2013 national change was 1.8 percent. The 2003-2013 compound annual growth rate for Pennsylvania real GDP was 1.1 percent; the compound annual growth rate for the nation was 1.5 percent.

GDP by State for Industries

In 2013, the largest industry in Pennsylvania was finance, insurance, real estate, rental, and leasing. This industry accounted for 19.0 percent of Pennsylvania GDP and had 0.8 percent real growth. The second largest industry was professional and business services, which accounted for 13.2 percent of Pennsylvania GDP and had 2.0 percent real growth.

The largest contributor to real GDP growth in Pennsylvania was professional and business services. This industry accounted for 0.26 percentage point of the total growth in real GDP. The second largest contributor was finance, insurance, real estate, rental, and leasing. This industry accounted for 0.16 percentage point of the total growth in real GDP.*

** The industry contributions, or sum thereof, may be larger than 100 percent (and the percentage points larger than the percent change) because growing and declining industries offset one another.*
