#### The Baselines

#### The Committee:

- Recognizes that the federal statistical system provides core data and infrastructure
- Acknowledges that Congress established aspects of the Evidence Commission-envisioned NSDS through the Evidence Act
- Asserts that the NSDS is designed to provide coordination and capacitybuilding services that supplement, not supplant, existing activities



#### The Baselines

#### Timely, actionable, and relevant recommendations:

- How does this recommendation fit within the existing ecosystem?
- How does it fit within the existing legal framework?

#### Detailed and nuanced findings:

- What relevant information has the Committee gathered?
- What are the Committee's findings based on that information?



#### **Synthesis and Integration**

#### Cohesive:

- How does this fit with the Year 1 report?
- How does this fit with other recommendations in the report?
- Does the report paint a consistent picture of the NSDS and its place in the existing ecosystem, operating under the CIPSEA legal framework?

#### Balanced:

- Does this reflect the Committee's different expert perspectives?
- Is this the right level of detail?

#### NSDS Organizational Structure and Governance



#### **Example: Clarified Key Considerations**

	NSDS Oversight and Advisory Bodies
People—the "who"	Who are the key NSDS stakeholders to provide oversight/advice to the NSDS?
Purpose—the "what"	What is the purpose of the advice from each group?
Placement—the "where"	At what level of the organizational structure is the oversight/advice most effective?
Power—the "how"	From what legal authority do bodies derive their ability to provide oversight/advice to the NSDS?
Phased implementation—the "when"	What is the legal framework that ultimately provides the right oversight by the right people to the right place in the organization? How to move from an initial structure to the target design?
Priorities	If advisory groups disagree, who decides the differences?
