



BEARFACTS 1989 – 1999

Clay , Texas [48077]

Clay is one of 254 counties in Texas. It is part of the [Wichita Falls, TX \(MSA\)](#). Its 1999 population of 10,673 ranked 162nd in the state.

PER CAPITA PERSONAL INCOME

In 1999 Clay had a per capita personal income (PCPI) of \$21,004. This PCPI ranked 117th in the state and was 80 percent of the state average, \$26,250, and 75 percent of the national average, \$27,939. The 1999 PCPI reflected an increase of 5.8 percent from 1998. The 1998-1999 state change was 4.2 percent and the national change was 3.9 percent. In 1989 the PCPI of Clay was \$14,033 and ranked 102nd in the state. The 1989-1999 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Clay had a total personal income (TPI) of \$224,179*. This TPI ranked 158th in the state and accounted for 0.0 percent of the state total. In 1989 the TPI of Clay was \$141,803* and ranked 156th in the state. The 1999 TPI reflected an increase of 5.8 percent from 1998. The 1998-1999 state change was 6.3 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 4.7 percent. The average annual growth rate for the state was 7.0 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Clay. In 1999 net earnings accounted for 66.2 percent of TPI (compared with 65.4 in 1989); dividends, interest, and rent were 17.8 percent (compared with 21.5 in 1989); and personal current transfer receipts were 16.0 percent (compared with 13.1 in 1989). From 1998 to 1999 net earnings increased 6.3 percent; dividends, interest, and rent increased 5.7 percent; and personal current transfer receipts increased 4.2 percent. From 1989 to 1999 net earnings increased on average 4.8 percent each year; dividends, interest, and rent increased on average 2.7 percent; and personal current transfer receipts increased on average 6.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Clay increased from \$80,583* in 1998 to \$92,358* in 1999, an increase of 14.6 percent. The 1998-1999 state change was 7.9 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$50,218* to the 1999 estimate was 6.3 percent. The average annual growth rate for the state was 7.5 percent and for the nation was 5.6 percent.
