



BEARFACTS 1989 – 1999

Henderson , Texas [48213]

Henderson is one of 254 counties in Texas. It is part of the Athens, TX Micropolitan SA. Its 1999 population of 72,080 ranked 45th in the state.

PER CAPITA PERSONAL INCOME

In 1999 Henderson had a per capita personal income (PCPI) of \$21,809. This PCPI ranked 97th in the state and was 83 percent of the state average, \$26,250, and 78 percent of the national average, \$27,939. The 1999 PCPI reflected an increase of 8.2 percent from 1998. The 1998-1999 state change was 4.2 percent and the national change was 3.9 percent. In 1989 the PCPI of Henderson was \$12,783 and ranked 161st in the state. The 1989-1999 average annual growth rate of PCPI was 5.5 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Henderson had a total personal income (TPI) of \$1,571,990*. This TPI ranked 45th in the state and accounted for 0.3 percent of the state total. In 1989 the TPI of Henderson was \$739,503* and ranked 46th in the state. The 1999 TPI reflected an increase of 10.9 percent from 1998. The 1998-1999 state change was 6.3 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 7.8 percent. The average annual growth rate for the state was 7.0 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Henderson. In 1999 net earnings accounted for 65.1 percent of TPI (compared with 61.5 in 1989); dividends, interest, and rent were 16.0 percent (compared with 23.0 in 1989); and personal current transfer receipts were 19.0 percent (compared with 15.5 in 1989). From 1998 to 1999 net earnings increased 16.5 percent; dividends, interest, and rent increased 0.7 percent; and personal current transfer receipts increased 2.6 percent. From 1989 to 1999 net earnings increased on average 8.4 percent each year; dividends, interest, and rent increased on average 4.0 percent; and personal current transfer receipts increased on average 10.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Henderson increased from \$511,103* in 1998 to \$578,841* in 1999, an increase of 13.3 percent. The 1998-1999 state change was 7.9 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$279,981* to the 1999 estimate was 7.5 percent. The average annual growth rate for the state was 7.5 percent and for the nation was 5.6 percent.
