



BEARFACTS 1989 – 1999

Palo Pinto , Texas [48363]

Palo Pinto is one of 254 counties in Texas. It is part of the Mineral Wells, TX Micropolitan SA. Its 1999 population of 26,720 ranked 93rd in the state.

PER CAPITA PERSONAL INCOME

In 1999 Palo Pinto had a per capita personal income (PCPI) of \$20,533. This PCPI ranked 127th in the state and was 78 percent of the state average, \$26,250, and 73 percent of the national average, \$27,939. The 1999 PCPI reflected an increase of 3.7 percent from 1998. The 1998-1999 state change was 4.2 percent and the national change was 3.9 percent. In 1989 the PCPI of Palo Pinto was \$13,100 and ranked 138th in the state. The 1989-1999 average annual growth rate of PCPI was 4.6 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Palo Pinto had a total personal income (TPI) of \$548,631*. This TPI ranked 92nd in the state and accounted for 0.1 percent of the state total. In 1989 the TPI of Palo Pinto was \$329,799* and ranked 88th in the state. The 1999 TPI reflected an increase of 5.0 percent from 1998. The 1998-1999 state change was 6.3 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 5.2 percent. The average annual growth rate for the state was 7.0 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Palo Pinto. In 1999 net earnings accounted for 63.4 percent of TPI (compared with 57.8 in 1989); dividends, interest, and rent were 17.2 percent (compared with 24.5 in 1989); and personal current transfer receipts were 19.5 percent (compared with 17.7 in 1989). From 1998 to 1999 net earnings increased 9.7 percent; dividends, interest, and rent decreased 5.6 percent; and personal current transfer receipts increased 1.2 percent. From 1989 to 1999 net earnings increased on average 6.2 percent each year; dividends, interest, and rent increased on average 1.6 percent; and personal current transfer receipts increased on average 6.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Palo Pinto increased from \$258,751* in 1998 to \$269,705* in 1999, an increase of 4.2 percent. The 1998-1999 state change was 7.9 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$166,288* to the 1999 estimate was 5.0 percent. The average annual growth rate for the state was 7.5 percent and for the nation was 5.6 percent.
