



BEARFACTS 1990 – 2000

Placer , California [06061]

Placer is one of 58 counties in California. It is part of the [Sacramento-Arden-Arcade-Roseville, CA \(MSA\)](#). Its 2000 population of 251,255 ranked 23rd in the state.

PER CAPITA PERSONAL INCOME

In 2000 Placer had a per capita personal income (PCPI) of \$36,429. This PCPI ranked 11th in the state and was 112 percent of the state average, \$32,467, and 122 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 5.2 percent from 1999. The 1999-2000 state change was 8.8 percent and the national change was 6.8 percent. In 1990 the PCPI of Placer was \$22,239 and ranked 12th in the state. The 1990-2000 average annual growth rate of PCPI was 5.1 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Placer had a total personal income (TPI) of \$9,153,080*. This TPI ranked 23rd in the state and accounted for 0.8 percent of the state total. In 1990 the TPI of Placer was \$3,902,481* and ranked 24th in the state. The 2000 TPI reflected an increase of 9.7 percent from 1999. The 1999-2000 state change was 10.5 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 8.9 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Placer. In 2000 net earnings accounted for 71.9 percent of TPI (compared with 69.9 in 1990); dividends, interest, and rent were 18.6 percent (compared with 19.8 in 1990); and personal current transfer receipts were 9.4 percent (compared with 10.3 in 1990). From 1999 to 2000 net earnings increased 9.7 percent; dividends, interest, and rent increased 9.4 percent; and personal current transfer receipts increased 10.2 percent. From 1990 to 2000 net earnings increased on average 9.2 percent each year; dividends, interest, and rent increased on average 8.2 percent; and personal current transfer receipts increased on average 8.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Placer increased from \$4,810,840* in 1999 to \$5,473,269* in 2000, an increase of 13.8 percent. The 1999-2000 state change was 11.8 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$2,179,291* to the 2000 estimate was 9.6 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.8 percent.
