



BEARFACTS 1990 – 2000

Cape Coral-Fort Myers (MSA) [15980]

Cape Coral-Fort Myers is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2000 population of 443,882 ranked 103rd in the nation.

PER CAPITA PERSONAL INCOME

In 2000 Cape Coral-Fort Myers had a per capita personal income (PCPI) of \$29,005. This PCPI ranked 95th in the United States and was 97 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 6.4 percent from 1999. The 1999-2000 national change was 6.8 percent. In 1990 the PCPI of Cape Coral-Fort Myers was \$20,134 and ranked 60th in the United States. The 1990-2000 average annual growth rate of PCPI was 3.7 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Cape Coral-Fort Myers had a total personal income (TPI) of \$12,874,770*. This TPI ranked 96th in the United States. In 1990 the TPI of Cape Coral-Fort Myers was \$6,825,681* and ranked 106th in the United States. The 2000 TPI reflected an increase of 9.3 percent from 1999. The 1999-2000 national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 6.6 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Cape Coral-Fort Myers. In 2000 net earnings accounted for 48.5 percent of TPI (compared with 46.0 in 1990); dividends, interest, and rent were 35.1 percent (compared with 38.6 in 1990); and personal current transfer receipts were 16.4 percent (compared with 15.4 in 1990). From 1999 to 2000 net earnings increased 8.5 percent; dividends, interest, and rent increased 11.2 percent; and personal current transfer receipts increased 7.6 percent. From 1990 to 2000 net earnings increased on average 7.1 percent each year; dividends, interest, and rent increased on average 5.5 percent; and personal current transfer receipts increased on average 7.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Cape Coral-Fort Myers increased from \$6,315,321* in 1999 to \$6,823,615* in 2000, an increase of 8.0 percent. The 1999-2000 national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$3,506,590* to the 2000 estimate was 6.9 percent. The average annual growth rate for the nation was 5.8 percent.
