



BEARFACTS 1990 – 2000

Pasquotank , North Carolina [37139]

Pasquotank is one of 100 counties in North Carolina. It is part of the Elizabeth City, NC Micropolitan SA. Its 2000 population of 34,906 ranked 63rd in the state.

PER CAPITA PERSONAL INCOME

In 2000 Pasquotank had a per capita personal income (PCPI) of \$20,799. This PCPI ranked 77th in the state and was 77 percent of the state average, \$27,067, and 70 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 5.0 percent from 1999. The 1999-2000 state change was 5.9 percent and the national change was 6.8 percent. In 1990 the PCPI of Pasquotank was \$14,565 and ranked 52nd in the state. The 1990-2000 average annual growth rate of PCPI was 3.6 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Pasquotank had a total personal income (TPI) of \$726,011*. This TPI ranked 66th in the state and accounted for 0.3 percent of the state total. In 1990 the TPI of Pasquotank was \$457,378* and ranked 61st in the state. The 2000 TPI reflected an increase of 5.0 percent from 1999. The 1999-2000 state change was 7.6 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 4.7 percent. The average annual growth rate for the state was 6.6 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Pasquotank. In 2000 net earnings accounted for 59.1 percent of TPI (compared with 63.3 in 1990); dividends, interest, and rent were 20.0 percent (compared with 20.4 in 1990); and personal current transfer receipts were 21.0 percent (compared with 16.3 in 1990). From 1999 to 2000 net earnings increased 5.8 percent; dividends, interest, and rent increased 3.0 percent; and personal current transfer receipts increased 4.5 percent. From 1990 to 2000 net earnings increased on average 4.0 percent each year; dividends, interest, and rent increased on average 4.5 percent; and personal current transfer receipts increased on average 7.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Pasquotank increased from \$506,790* in 1999 to \$543,621* in 2000, an increase of 7.3 percent. The 1999-2000 state change was 7.4 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$320,434* to the 2000 estimate was 5.4 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.8 percent.
