



BEARFACTS 1991 – 2001

Placer , California [06061]

Placer is one of 58 counties in California. It is part of the [Sacramento-Arden-Arcade-Roseville, CA \(MSA\)](#). Its 2001 population of 264,212 ranked 22nd in the state.

PER CAPITA PERSONAL INCOME

In 2001 Placer had a per capita personal income (PCPI) of \$37,151. This PCPI ranked 10th in the state and was 113 percent of the state average, \$32,901, and 121 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 2.0 percent from 2000. The 2000-2001 state change was 1.3 percent and the national change was 2.5 percent. In 1991 the PCPI of Placer was \$22,832 and ranked 10th in the state. The 1991-2001 average annual growth rate of PCPI was 5.0 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Placer had a total personal income (TPI) of \$9,815,673*. This TPI ranked 22nd in the state and accounted for 0.9 percent of the state total. In 1991 the TPI of Placer was \$4,146,547* and ranked 24th in the state. The 2001 TPI reflected an increase of 7.2 percent from 2000. The 2000-2001 state change was 2.9 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 9.0 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Placer. In 2001 net earnings accounted for 70.7 percent of TPI (compared with 69.6 in 1991); dividends, interest, and rent were 19.2 percent (compared with 19.5 in 1991); and personal current transfer receipts were 10.1 percent (compared with 10.9 in 1991). From 2000 to 2001 net earnings increased 5.5 percent; dividends, interest, and rent increased 10.4 percent; and personal current transfer receipts increased 14.5 percent. From 1991 to 2001 net earnings increased on average 9.2 percent each year; dividends, interest, and rent increased on average 8.8 percent; and personal current transfer receipts increased on average 8.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Placer increased from \$5,473,269* in 2000 to \$6,075,262* in 2001, an increase of 11.0 percent. The 2000-2001 state change was 1.9 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$2,335,963* to the 2001 estimate was 10.0 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.8 percent.
