



BEARFACTS 1991 – 2001

Madison , Iowa [19121]

Madison is one of 99 counties in Iowa. It is part of the [Des Moines-West Des Moines, IA \(MSA\)](#). Its 2001 population of 14,150 ranked 58th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Madison had a per capita personal income (PCPI) of \$26,476. This PCPI ranked 24th in the state and was 98 percent of the state average, \$27,125, and 87 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 6.3 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Madison was \$16,741 and ranked 38th in the state. The 1991-2001 average annual growth rate of PCPI was 4.7 percent. The average annual growth rate for the state was 4.3 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Madison had a total personal income (TPI) of \$374,639*. This TPI ranked 55th in the state and accounted for 0.5 percent of the state total. In 1991 the TPI of Madison was \$210,066* and ranked 63rd in the state. The 2001 TPI reflected an increase of 7.0 percent from 2000. The 2000-2001 state change was 2.2 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.0 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Madison. In 2001 net earnings accounted for 68.9 percent of TPI (compared with 65.3 in 1991); dividends, interest, and rent were 17.1 percent (compared with 19.8 in 1991); and personal current transfer receipts were 14.0 percent (compared with 14.9 in 1991). From 2000 to 2001 net earnings increased 8.5 percent; dividends, interest, and rent increased 2.1 percent; and personal current transfer receipts increased 5.8 percent. From 1991 to 2001 net earnings increased on average 6.5 percent each year; dividends, interest, and rent increased on average 4.4 percent; and personal current transfer receipts increased on average 5.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Madison increased from \$124,594* in 2000 to \$141,854* in 2001, an increase of 13.9 percent. The 2000-2001 state change was 1.7 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$74,091* to the 2001 estimate was 6.7 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.8 percent.
