



BEARFACTS 1991 – 2001

Van Buren , Iowa [19177]

Van Buren is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2001 population of 7,736 ranked 92nd in the state.

PER CAPITA PERSONAL INCOME

In 2001 Van Buren had a per capita personal income (PCPI) of \$19,776. This PCPI ranked 97th in the state and was 73 percent of the state average, \$27,125, and 65 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 1.8 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Van Buren was \$14,113 and ranked 93rd in the state. The 1991-2001 average annual growth rate of PCPI was 3.4 percent. The average annual growth rate for the state was 4.3 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Van Buren had a total personal income (TPI) of \$152,989*. This TPI ranked 95th in the state and accounted for 0.2 percent of the state total. In 1991 the TPI of Van Buren was \$108,927* and ranked 94th in the state. The 2001 TPI reflected a decrease of 2.8 percent from 2000. The 2000-2001 state change was 2.2 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 3.5 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Van Buren. In 2001 net earnings accounted for 53.5 percent of TPI (compared with 55.9 in 1991); dividends, interest, and rent were 22.6 percent (compared with 23.4 in 1991); and personal current transfer receipts were 23.9 percent (compared with 20.7 in 1991). From 2000 to 2001 net earnings decreased 10.3 percent; dividends, interest, and rent increased 5.5 percent; and personal current transfer receipts increased 9.2 percent. From 1991 to 2001 net earnings increased on average 3.0 percent each year; dividends, interest, and rent increased on average 3.1 percent; and personal current transfer receipts increased on average 5.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Van Buren decreased from \$72,548* in 2000 to \$64,998* in 2001, a decrease of 10.4 percent. The 2000-2001 state change was 1.7 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$49,409* to the 2001 estimate was 2.8 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.8 percent.
