



BEARFACTS 1991 – 2001 Concordia , Louisiana [22029]

Concordia is one of 64 counties in Louisiana. It is part of the Natchez, MS-LA Micropolitan SA. Its 2001 population of 19,931 ranked 48th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Concordia had a per capita personal income (PCPI) of \$17,587. This PCPI ranked 58th in the state and was 71 percent of the state average, \$24,719, and 58 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 9.5 percent from 2000. The 2000-2001 state change was 7.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Concordia was \$11,966 and ranked 52nd in the state. The 1991-2001 average annual growth rate of PCPI was 3.9 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Concordia had a total personal income (TPI) of \$350,526*. This TPI ranked 50th in the state and accounted for 0.3 percent of the state total. In 1991 the TPI of Concordia was \$246,882* and ranked 47th in the state. The 2001 TPI reflected an increase of 8.0 percent from 2000. The 2000-2001 state change was 6.9 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 3.6 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Concordia. In 2001 net earnings accounted for 51.4 percent of TPI (compared with 59.2 in 1991); dividends, interest, and rent were 18.6 percent (compared with 17.3 in 1991); and personal current transfer receipts were 30.0 percent (compared with 23.6 in 1991). From 2000 to 2001 net earnings increased 1.3 percent; dividends, interest, and rent increased 10.3 percent; and personal current transfer receipts increased 20.0 percent. From 1991 to 2001 net earnings increased on average 2.1 percent each year; dividends, interest, and rent increased on average 4.3 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Concordia increased from \$162,474* in 2000 to \$163,863* in 2001, an increase of 0.9 percent. The 2000-2001 state change was 6.6 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$119,876* to the 2001 estimate was 3.2 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.8 percent.
