



BEARFACTS 1991 – 2001

Wilkin , Minnesota [27167]

Wilkin is one of 87 counties in Minnesota. It is part of the Wahpeton, ND-MN Micropolitan SA. Its 2001 population of 6,961 ranked 78th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Wilkin had a per capita personal income (PCPI) of \$22,268. This PCPI ranked 74th in the state and was 68 percent of the state average, \$32,631, and 73 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 1.5 percent from 2000. The 2000-2001 state change was 1.9 percent and the national change was 2.5 percent. In 1991 the PCPI of Wilkin was \$15,112 and ranked 66th in the state. The 1991-2001 average annual growth rate of PCPI was 4.0 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Wilkin had a total personal income (TPI) of \$155,010*. This TPI ranked 78th in the state and accounted for 0.1 percent of the state total. In 1991 the TPI of Wilkin was \$112,145* and ranked 77th in the state. The 2001 TPI reflected a decrease of 3.7 percent from 2000. The 2000-2001 state change was 2.9 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 3.3 percent. The average annual growth rate for the state was 6.1 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Wilkin. In 2001 net earnings accounted for 52.2 percent of TPI (compared with 54.0 in 1991); dividends, interest, and rent were 27.4 percent (compared with 27.1 in 1991); and personal current transfer receipts were 20.4 percent (compared with 19.0 in 1991). From 2000 to 2001 net earnings decreased 12.4 percent; dividends, interest, and rent increased 7.3 percent; and personal current transfer receipts increased 9.2 percent. From 1991 to 2001 net earnings increased on average 3.0 percent each year; dividends, interest, and rent increased on average 3.4 percent; and personal current transfer receipts increased on average 4.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Wilkin decreased from \$77,658* in 2000 to \$67,773* in 2001, a decrease of 12.7 percent. The 2000-2001 state change was 3.0 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$58,531* to the 2001 estimate was 1.5 percent. The average annual growth rate for the state was 6.3 percent and for the nation was 5.8 percent.
