



BEARFACTS 1991 – 2001

Las Cruces (MSA) [29740]

Las Cruces is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2001 population of 176,536 ranked 213th in the nation.

PER CAPITA PERSONAL INCOME

In 2001 Las Cruces had a per capita personal income (PCPI) of \$19,599. This PCPI ranked 356th in the United States and was 64 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 9.9 percent from 2000. The 2000-2001 national change was 2.5 percent. In 1991 the PCPI of Las Cruces was \$13,081 and ranked 360th in the United States. The 1991-2001 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Las Cruces had a total personal income (TPI) of \$3,460,005*. This TPI ranked 263rd in the United States. In 1991 the TPI of Las Cruces was \$1,847,414* and ranked 285th in the United States. The 2001 TPI reflected an increase of 10.9 percent from 2000. The 2000-2001 national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.5 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Las Cruces. In 2001 net earnings accounted for 62.7 percent of TPI (compared with 66.4 in 1991); dividends, interest, and rent were 17.7 percent (compared with 18.9 in 1991); and personal current transfer receipts were 19.5 percent (compared with 14.8 in 1991). From 2000 to 2001 net earnings increased 9.3 percent; dividends, interest, and rent increased 11.9 percent; and personal current transfer receipts increased 15.4 percent. From 1991 to 2001 net earnings increased on average 5.9 percent each year; dividends, interest, and rent increased on average 5.8 percent; and personal current transfer receipts increased on average 9.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Las Cruces increased from \$1,988,756* in 2000 to \$2,168,635* in 2001, an increase of 9.0 percent. The 2000-2001 national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$1,277,668* to the 2001 estimate was 5.4 percent. The average annual growth rate for the nation was 5.8 percent.
