



BEARFACTS 1991 – 2001

Storey , Nevada [32029]

Storey is one of 17 counties in Nevada. It is part of the [Reno-Sparks, NV \(MSA\)](#). Its 2001 population of 3,416 ranked 15th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Storey had a per capita personal income (PCPI) of \$29,262. This PCPI ranked 5th in the state and was 95 percent of the state average, \$30,739, and 96 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 3.6 percent from 2000. The 2000-2001 state change was 1.0 percent and the national change was 2.5 percent. In 1991 the PCPI of Storey was \$18,983 and ranked 9th in the state. The 1991-2001 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Storey had a total personal income (TPI) of \$99,959*. This TPI ranked 14th in the state and accounted for 0.2 percent of the state total. In 1991 the TPI of Storey was \$49,981* and ranked 15th in the state. The 2001 TPI reflected an increase of 4.3 percent from 2000. The 2000-2001 state change was 4.8 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 7.2 percent. The average annual growth rate for the state was 9.1 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Storey. In 2001 net earnings accounted for 70.9 percent of TPI (compared with 77.0 in 1991); dividends, interest, and rent were 20.2 percent (compared with 13.9 in 1991); and personal current transfer receipts were 8.9 percent (compared with 9.0 in 1991). From 2000 to 2001 net earnings increased 2.8 percent; dividends, interest, and rent increased 11.7 percent; and personal current transfer receipts increased 0.5 percent. From 1991 to 2001 net earnings increased on average 6.3 percent each year; dividends, interest, and rent increased on average 11.2 percent; and personal current transfer receipts increased on average 7.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Storey increased from \$39,538* in 2000 to \$40,454* in 2001, an increase of 2.3 percent. The 2000-2001 state change was 4.4 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$21,434* to the 2001 estimate was 6.6 percent. The average annual growth rate for the state was 9.0 percent and for the nation was 5.8 percent.
