



BEARFACTS 1991 – 2001

Paulding , Ohio [39125]

Paulding is one of 88 counties in Ohio. It is not part of a Metropolitan Area. Its 2001 population of 20,091 ranked 83rd in the state.

PER CAPITA PERSONAL INCOME

In 2001 Paulding had a per capita personal income (PCPI) of \$22,162. This PCPI ranked 70th in the state and was 78 percent of the state average, \$28,585, and 72 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 1.6 percent from 2000. The 2000-2001 state change was 1.3 percent and the national change was 2.5 percent. In 1991 the PCPI of Paulding was \$14,664 and ranked 64th in the state. The 1991-2001 average annual growth rate of PCPI was 4.2 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Paulding had a total personal income (TPI) of \$445,255*. This TPI ranked 83rd in the state and accounted for 0.1 percent of the state total. In 1991 the TPI of Paulding was \$298,596* and ranked 81st in the state. The 2001 TPI reflected a decrease of 2.3 percent from 2000. The 2000-2001 state change was 1.6 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 4.1 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Paulding. In 2001 net earnings accounted for 67.2 percent of TPI (compared with 67.9 in 1991); dividends, interest, and rent were 15.9 percent (compared with 16.0 in 1991); and personal current transfer receipts were 16.9 percent (compared with 16.1 in 1991). From 2000 to 2001 net earnings decreased 5.4 percent; dividends, interest, and rent increased 0.3 percent; and personal current transfer receipts increased 9.5 percent. From 1991 to 2001 net earnings increased on average 4.0 percent each year; dividends, interest, and rent increased on average 4.0 percent; and personal current transfer receipts increased on average 4.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Paulding increased from \$180,183* in 2000 to \$182,334* in 2001, an increase of 1.2 percent. The 2000-2001 state change was 1.3 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$117,721* to the 2001 estimate was 4.5 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.8 percent.
