



BEARFACTS 1991 – 2001 Cimarron , Oklahoma [40025]

Cimarron is one of 77 counties in Oklahoma. It is not part of a Metropolitan Area. Its 2001 population of 3,056 ranked 77th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Cimarron had a per capita personal income (PCPI) of \$20,954. This PCPI ranked 43rd in the state and was 80 percent of the state average, \$26,033, and 69 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 2.5 percent from 2000. The 2000-2001 state change was 6.6 percent and the national change was 2.5 percent. In 1991 the PCPI of Cimarron was \$20,810 and ranked 3rd in the state. The 1991-2001 average annual growth rate of PCPI was 0.1 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Cimarron had a total personal income (TPI) of \$64,034*. This TPI ranked 77th in the state and accounted for 0.1 percent of the state total. In 1991 the TPI of Cimarron was \$67,404* and ranked 73rd in the state. The 2001 TPI reflected a decrease of 5.4 percent from 2000. The 2000-2001 state change was 6.9 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was - 0.5 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Cimarron. In 2001 net earnings accounted for 52.2 percent of TPI (compared with 68.2 in 1991); dividends, interest, and rent were 29.8 percent (compared with 20.4 in 1991); and personal current transfer receipts were 17.9 percent (compared with 11.4 in 1991). From 2000 to 2001 net earnings decreased 10.6 percent; dividends, interest, and rent decreased 0.6 percent; and personal current transfer receipts increased 3.9 percent. From 1991 to 2001 net earnings decreased on average 3.1 percent each year; dividends, interest, and rent increased on average 3.3 percent; and personal current transfer receipts increased on average 4.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Cimarron decreased from \$38,181* in 2000 to \$34,034* in 2001, a decrease of 10.9 percent. The 2000-2001 state change was 7.7 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$48,863* to the 2001 estimate was - 3.6 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.8 percent.
