



BEARFACTS 1992 – 2002

Albuquerque (MSA) [10740]

Albuquerque is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2002 population of 753,834 ranked 65th in the nation.

PER CAPITA PERSONAL INCOME

In 2002 Albuquerque had a per capita personal income (PCPI) of \$27,836. This PCPI ranked 155th in the United States and was 90 percent of the national average, \$30,821. The 2002 PCPI reflected a decrease of 0.5 percent from 2001. The 2001-2002 national change was 0.8 percent. In 1992 the PCPI of Albuquerque was \$18,502 and ranked 174th in the United States. The 1992-2002 average annual growth rate of PCPI was 4.2 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Albuquerque had a total personal income (TPI) of \$20,983,664*. This TPI ranked 66th in the United States. In 1992 the TPI of Albuquerque was \$11,712,475* and ranked 72nd in the United States. The 2002 TPI reflected an increase of 1.4 percent from 2001. The 2001-2002 national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 6.0 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Albuquerque. In 2002 net earnings accounted for 69.9 percent of TPI (compared with 68.8 in 1992); dividends, interest, and rent were 15.4 percent (compared with 18.5 in 1992); and personal current transfer receipts were 14.7 percent (compared with 12.7 in 1992). From 2001 to 2002 net earnings increased 2.6 percent; dividends, interest, and rent decreased 10.2 percent; and personal current transfer receipts increased 10.4 percent. From 1992 to 2002 net earnings increased on average 6.2 percent each year; dividends, interest, and rent increased on average 4.1 percent; and personal current transfer receipts increased on average 7.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Albuquerque increased from \$15,996,059* in 2001 to \$16,401,570* in 2002, an increase of 2.5 percent. The 2001-2002 national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$9,001,081* to the 2002 estimate was 6.2 percent. The average annual growth rate for the nation was 5.4 percent.
