



BEARFACTS 1992 – 2002

Holt , Missouri [29087]

Holt is one of 115 counties in Missouri. It is not part of a Metropolitan Area. Its 2002 population of 5,137 ranked 110th in the state.

PER CAPITA PERSONAL INCOME

In 2002 Holt had a per capita personal income (PCPI) of \$21,664. This PCPI ranked 48th in the state and was 76 percent of the state average, \$28,385, and 70 percent of the national average, \$30,838. The 2002 PCPI reflected a decrease of 1.0 percent from 2001. The 2001-2002 state change was 2.0 percent and the national change was 0.8 percent. In 1992 the PCPI of Holt was \$16,701 and ranked 20th in the state. The 1992-2002 average annual growth rate of PCPI was 2.6 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Holt had a total personal income (TPI) of \$111,290*. This TPI ranked 108th in the state and accounted for 0.1 percent of the state total. In 1992 the TPI of Holt was \$98,320* and ranked 104th in the state. The 2002 TPI reflected a decrease of 4.1 percent from 2001. The 2001-2002 state change was 2.7 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 1.2 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Holt. In 2002 net earnings accounted for 52.5 percent of TPI (compared with 56.1 in 1992); dividends, interest, and rent were 20.8 percent (compared with 23.5 in 1992); and personal current transfer receipts were 26.7 percent (compared with 20.4 in 1992). From 2001 to 2002 net earnings decreased 2.5 percent; dividends, interest, and rent decreased 16.2 percent; and personal current transfer receipts increased 4.2 percent. From 1992 to 2002 net earnings increased on average 0.6 percent each year; dividends, interest, and rent remained unchanged; and personal current transfer receipts increased on average 4.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Holt decreased from \$44,687* in 2001 to \$42,868* in 2002, a decrease of 4.1 percent. The 2001-2002 state change was 3.1 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$50,494* to the 2002 estimate was - 1.6 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.4 percent.
