



BEARFACTS 1992 – 2002

Shelby , Missouri [29205]

Shelby is one of 115 counties in Missouri. It is not part of a Metropolitan Area. Its 2002 population of 6,714 ranked 104th in the state.

PER CAPITA PERSONAL INCOME

In 2002 Shelby had a per capita personal income (PCPI) of \$21,061. This PCPI ranked 58th in the state and was 74 percent of the state average, \$28,385, and 68 percent of the national average, \$30,838. The 2002 PCPI reflected a decrease of 7.2 percent from 2001. The 2001-2002 state change was 2.0 percent and the national change was 0.8 percent. In 1992 the PCPI of Shelby was \$16,207 and ranked 26th in the state. The 1992-2002 average annual growth rate of PCPI was 2.7 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Shelby had a total personal income (TPI) of \$141,405*. This TPI ranked 103rd in the state and accounted for 0.1 percent of the state total. In 1992 the TPI of Shelby was \$111,874* and ranked 97th in the state. The 2002 TPI reflected a decrease of 8.1 percent from 2001. The 2001-2002 state change was 2.7 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 2.4 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Shelby. In 2002 net earnings accounted for 53.9 percent of TPI (compared with 52.1 in 1992); dividends, interest, and rent were 21.2 percent (compared with 26.7 in 1992); and personal current transfer receipts were 24.9 percent (compared with 21.2 in 1992). From 2001 to 2002 net earnings decreased 11.4 percent; dividends, interest, and rent decreased 12.7 percent; and personal current transfer receipts increased 5.2 percent. From 1992 to 2002 net earnings increased on average 2.7 percent each year; dividends, interest, and rent remained unchanged; and personal current transfer receipts increased on average 4.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Shelby decreased from \$77,687* in 2001 to \$63,913* in 2002, a decrease of 17.7 percent. The 2001-2002 state change was 3.1 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$57,241* to the 2002 estimate was 1.1 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.4 percent.
