



BEARFACTS 1992 – 2002 Orleans , New York [36073]

Orleans is one of 62 counties in New York. It is part of the [Rochester, NY \(MSA\)](#). Its 2002 population of 43,407 ranked 54th in the state.

PER CAPITA PERSONAL INCOME

In 2002 Orleans had a per capita personal income (PCPI) of \$20,690. This PCPI ranked 57th in the state and was 59 percent of the state average, \$35,363, and 67 percent of the national average, \$30,838. The 2002 PCPI remained unchanged from 2001. The 2001-2002 state change was -0.7 percent and the national change was 0.8 percent. In 1992 the PCPI of Orleans was \$15,833 and ranked 50th in the state. The 1992-2002 average annual growth rate of PCPI was 2.7 percent. The average annual growth rate for the state was 3.6 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Orleans had a total personal income (TPI) of \$898,093*. This TPI ranked 55th in the state and accounted for 0.1 percent of the state total. In 1992 the TPI of Orleans was \$691,506* and ranked 54th in the state. The 2002 TPI reflected a decrease of 0.6 percent from 2001. The 2001-2002 state change was - 0.3 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 2.6 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Orleans. In 2002 net earnings accounted for 64.6 percent of TPI (compared with 67.5 in 1992); dividends, interest, and rent were 12.2 percent (compared with 14.7 in 1992); and personal current transfer receipts were 23.2 percent (compared with 17.7 in 1992). From 2001 to 2002 net earnings increased 0.3 percent; dividends, interest, and rent decreased 19.5 percent; and personal current transfer receipts increased 10.2 percent. From 1992 to 2002 net earnings increased on average 2.2 percent each year; dividends, interest, and rent increased on average 0.7 percent; and personal current transfer receipts increased on average 5.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Orleans increased from \$448,363* in 2001 to \$463,527* in 2002, an increase of 3.4 percent. The 2001-2002 state change was - 0.3 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$343,704* to the 2002 estimate was 3.0 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.4 percent.
