



BEARFACTS 1992 – 2002

Houston-Baytown-Huntsville (BEA-EA) [57075]

Houston-Baytown-Huntsville is one of 179 BEA Economic Areas in the nation. Its 2002 population of 5,866,822 ranked 11th in the nation.

PER CAPITA PERSONAL INCOME

In 2002 Houston-Baytown-Huntsville had a per capita personal income (PCPI) of \$32,724. This PCPI ranked 13th in the United States and was 106 percent of the national average, \$30,838. The 2002 PCPI reflected a decrease of 2.1 percent from 2001. The 2001-2002 national change was 0.8 percent. In 1992 the PCPI of Houston-Baytown-Huntsville was \$20,977 and ranked 20th in the United States. The 1992-2002 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Houston-Baytown-Huntsville had a total personal income (TPI) of \$191,988,092*. This TPI ranked 11th in the United States. In 1992 the TPI of Houston-Baytown-Huntsville was \$100,535,464* and ranked 11th in the United States. The 2002 TPI reflected an increase of 0.1 percent from 2001. The 2001-2002 national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 6.7 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Houston-Baytown-Huntsville. In 2002 net earnings accounted for 77.5 percent of TPI (compared with 74.8 in 1992); dividends, interest, and rent were 12.4 percent (compared with 15.2 in 1992); and personal current transfer receipts were 10.1 percent (compared with 10.0 in 1992). From 2001 to 2002 net earnings decreased 0.6 percent; dividends, interest, and rent decreased 1.1 percent; and personal current transfer receipts increased 8.1 percent. From 1992 to 2002 net earnings increased on average 7.1 percent each year; dividends, interest, and rent increased on average 4.6 percent; and personal current transfer receipts increased on average 6.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Houston-Baytown-Huntsville decreased from \$166,070,559* in 2001 to \$165,246,073* in 2002, a decrease of 0.5 percent. The 2001-2002 national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$84,057,356* to the 2002 estimate was 7.0 percent. The average annual growth rate for the nation was 5.4 percent.
