



BEARFACTS 1993 – 2003

Charleston-North Charleston-Summerville (MSA) [16700]

Charleston-North Charleston-Summerville is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2003 population of 576,651 ranked 83rd in the nation.

PER CAPITA PERSONAL INCOME

In 2003 Charleston-North Charleston-Summerville had a per capita personal income (PCPI) of \$27,338. This PCPI ranked 189th in the United States and was 87 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 2.3 percent from 2002. The 2002-2003 national change was 2.2 percent. In 1993 the PCPI of Charleston-North Charleston-Summerville was \$17,775 and ranked 256th in the United States. The 1993-2003 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Charleston-North Charleston-Summerville had a total personal income (TPI) of \$15,764,753*. This TPI ranked 85th in the United States. In 1993 the TPI of Charleston-North Charleston-Summerville was \$9,454,627* and ranked 88th in the United States. The 2003 TPI reflected an increase of 4.1 percent from 2002. The 2002-2003 national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 5.2 percent. The average annual growth rate for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Charleston-North Charleston-Summerville. In 2003 net earnings accounted for 69.8 percent of TPI (compared with 70.4 in 1993); dividends, interest, and rent were 14.9 percent (compared with 17.0 in 1993); and personal current transfer receipts were 15.3 percent (compared with 12.6 in 1993). From 2002 to 2003 net earnings increased 5.6 percent; dividends, interest, and rent decreased 3.7 percent; and personal current transfer receipts increased 5.6 percent. From 1993 to 2003 net earnings increased on average 5.2 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 7.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Charleston-North Charleston-Summerville increased from \$11,736,120* in 2002 to \$12,399,577* in 2003, an increase of 5.7 percent. The 2002-2003 national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$7,531,855* to the 2003 estimate was 5.1 percent. The average annual growth rate for the nation was 5.3 percent.
