



BEARFACTS 1993 – 2003

Cloud , Kansas [20029]

Cloud is one of 105 counties in Kansas. It is not part of a Metropolitan Area. Its 2003 population of 9,794 ranked 43rd in the state.

PER CAPITA PERSONAL INCOME

In 2003 Cloud had a per capita personal income (PCPI) of \$22,883. This PCPI ranked 85th in the state and was 77 percent of the state average, \$29,802, and 73 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 4.9 percent from 2002. The 2002-2003 state change was 2.8 percent and the national change was 2.2 percent. In 1993 the PCPI of Cloud was \$16,439 and ranked 77th in the state. The 1993-2003 average annual growth rate of PCPI was 3.4 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Cloud had a total personal income (TPI) of \$224,119*. This TPI ranked 46th in the state and accounted for 0.3 percent of the state total. In 1993 the TPI of Cloud was \$178,194* and ranked 41st in the state. The 2003 TPI reflected an increase of 3.9 percent from 2002. The 2002-2003 state change was 3.2 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 2.3 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Cloud. In 2003 net earnings accounted for 52.5 percent of TPI (compared with 53.1 in 1993); dividends, interest, and rent were 21.3 percent (compared with 23.7 in 1993); and personal current transfer receipts were 26.2 percent (compared with 23.2 in 1993). From 2002 to 2003 net earnings increased 15.7 percent; dividends, interest, and rent decreased 15.2 percent; and personal current transfer receipts increased 1.8 percent. From 1993 to 2003 net earnings increased on average 2.2 percent each year; dividends, interest, and rent increased on average 1.3 percent; and personal current transfer receipts increased on average 3.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Cloud increased from \$108,833* in 2002 to \$125,526* in 2003, an increase of 15.3 percent. The 2002-2003 state change was 5.0 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$104,381* to the 2003 estimate was 1.9 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.3 percent.
