



BEARFACTS 1993 – 2003 Republic , Kansas [20157]

Republic is one of 105 counties in Kansas. It is not part of a Metropolitan Area. Its 2003 population of 5,299 ranked 69th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Republic had a per capita personal income (PCPI) of \$24,009. This PCPI ranked 73rd in the state and was 81 percent of the state average, \$29,802, and 76 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 10.1 percent from 2002. The 2002-2003 state change was 2.8 percent and the national change was 2.2 percent. In 1993 the PCPI of Republic was \$19,388 and ranked 28th in the state. The 1993-2003 average annual growth rate of PCPI was 2.2 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Republic had a total personal income (TPI) of \$127,223*. This TPI ranked 72nd in the state and accounted for 0.2 percent of the state total. In 1993 the TPI of Republic was \$119,951* and ranked 60th in the state. The 2003 TPI reflected an increase of 7.6 percent from 2002. The 2002-2003 state change was 3.2 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 0.6 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Republic. In 2003 net earnings accounted for 54.5 percent of TPI (compared with 58.8 in 1993); dividends, interest, and rent were 21.7 percent (compared with 22.3 in 1993); and personal current transfer receipts were 23.8 percent (compared with 18.9 in 1993). From 2002 to 2003 net earnings increased 19.2 percent; dividends, interest, and rent decreased 10.3 percent; and personal current transfer receipts increased 3.4 percent. From 1993 to 2003 net earnings decreased on average 0.2 percent each year; dividends, interest, and rent increased on average 0.3 percent; and personal current transfer receipts increased on average 3.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Republic increased from \$64,496* in 2002 to \$74,611* in 2003, an increase of 15.7 percent. The 2002-2003 state change was 5.0 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$74,952* to the 2003 estimate was - 0.0 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.3 percent.
