



BEARFACTS 1993 – 2003

Prince George's , Maryland [24033]

Prince George's is one of 24 counties in Maryland. It is part of the [Washington-Arlington-Alexandria, DC-VA-MD-WV \(MSA\)](#). Its 2003 population of 828,822 ranked 2nd in the state.

PER CAPITA PERSONAL INCOME

In 2003 Prince George's had a per capita personal income (PCPI) of \$31,668. This PCPI ranked 13th in the state and was 85 percent of the state average, \$37,441, and 100 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 2.4 percent from 2002. The 2002-2003 state change was 2.4 percent and the national change was 2.2 percent. In 1993 the PCPI of Prince George's was \$23,135 and ranked 7th in the state. The 1993-2003 average annual growth rate of PCPI was 3.2 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Prince George's had a total personal income (TPI) of \$26,246,868*. This TPI ranked 3rd in the state and accounted for 12.8 percent of the state total. In 1993 the TPI of Prince George's was \$17,426,756* and ranked 3rd in the state. The 2003 TPI reflected an increase of 3.2 percent from 2002. The 2002-2003 state change was 3.5 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 4.2 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Prince George's. In 2003 net earnings accounted for 78.4 percent of TPI (compared with 78.9 in 1993); dividends, interest, and rent were 11.1 percent (compared with 13.0 in 1993); and personal current transfer receipts were 10.5 percent (compared with 8.1 in 1993). From 2002 to 2003 net earnings increased 3.2 percent; dividends, interest, and rent decreased 1.4 percent; and personal current transfer receipts increased 7.8 percent. From 1993 to 2003 net earnings increased on average 4.1 percent each year; dividends, interest, and rent increased on average 2.6 percent; and personal current transfer receipts increased on average 7.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Prince George's increased from \$17,742,687* in 2002 to \$18,265,450* in 2003, an increase of 2.9 percent. The 2002-2003 state change was 4.3 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$11,145,222* to the 2003 estimate was 5.1 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.3 percent.
