



BEARFACTS 1993 – 2003

Kittson , Minnesota [27069]

Kittson is one of 87 counties in Minnesota. It is not part of a Metropolitan Area. Its 2003 population of 4,894 ranked 84th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Kittson had a per capita personal income (PCPI) of \$31,411. This PCPI ranked 9th in the state and was 91 percent of the state average, \$34,378, and 100 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 26.3 percent from 2002. The 2002-2003 state change was 3.3 percent and the national change was 2.2 percent. In 1993 the PCPI of Kittson was \$14,841 and ranked 69th in the state. The 1993-2003 average annual growth rate of PCPI was 7.8 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Kittson had a total personal income (TPI) of \$153,724*. This TPI ranked 81st in the state and accounted for 0.1 percent of the state total. In 1993 the TPI of Kittson was \$83,004* and ranked 82nd in the state. The 2003 TPI reflected an increase of 23.1 percent from 2002. The 2002-2003 state change was 3.9 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 6.4 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Kittson. In 2003 net earnings accounted for 63.0 percent of TPI (compared with 46.0 in 1993); dividends, interest, and rent were 18.5 percent (compared with 29.9 in 1993); and personal current transfer receipts were 18.5 percent (compared with 24.1 in 1993). From 2002 to 2003 net earnings increased 42.9 percent; dividends, interest, and rent decreased 3.9 percent; and personal current transfer receipts increased 3.5 percent. From 1993 to 2003 net earnings increased on average 9.8 percent each year; dividends, interest, and rent increased on average 1.4 percent; and personal current transfer receipts increased on average 3.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Kittson increased from \$63,066* in 2002 to \$91,957* in 2003, an increase of 45.8 percent. The 2002-2003 state change was 4.0 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$37,164* to the 2003 estimate was 9.5 percent. The average annual growth rate for the state was 5.9 percent and for the nation was 5.3 percent.
