



BEARFACTS 1993 – 2003

Tallahatchie , Mississippi [28135]

Tallahatchie is one of 82 counties in Mississippi. It is not part of a Metropolitan Area. Its 2003 population of 14,184 ranked 59th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Tallahatchie had a per capita personal income (PCPI) of \$19,374. This PCPI ranked 51st in the state and was 84 percent of the state average, \$23,129, and 61 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 17.1 percent from 2002. The 2002-2003 state change was 3.3 percent and the national change was 2.2 percent. In 1993 the PCPI of Tallahatchie was \$11,315 and ranked 74th in the state. The 1993-2003 average annual growth rate of PCPI was 5.5 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Tallahatchie had a total personal income (TPI) of \$274,804*. This TPI ranked 61st in the state and accounted for 0.4 percent of the state total. In 1993 the TPI of Tallahatchie was \$169,140* and ranked 59th in the state. The 2003 TPI reflected an increase of 15.4 percent from 2002. The 2002-2003 state change was 3.6 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 5.0 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Tallahatchie. In 2003 net earnings accounted for 56.2 percent of TPI (compared with 53.4 in 1993); dividends, interest, and rent were 13.2 percent (compared with 15.3 in 1993); and personal current transfer receipts were 30.7 percent (compared with 31.3 in 1993). From 2002 to 2003 net earnings increased 29.1 percent; dividends, interest, and rent remained unchanged; and personal current transfer receipts increased 2.4 percent. From 1993 to 2003 net earnings increased on average 5.5 percent each year; dividends, interest, and rent increased on average 3.4 percent; and personal current transfer receipts increased on average 4.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Tallahatchie increased from \$74,137* in 2002 to \$108,812* in 2003, an increase of 46.8 percent. The 2002-2003 state change was 5.6 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$67,786* to the 2003 estimate was 4.8 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.3 percent.
