



BEARFACTS 1993 – 2003

Tishomingo , Mississippi [28141]

Tishomingo is one of 82 counties in Mississippi. It is not part of a Metropolitan Area. Its 2003 population of 18,863 ranked 53rd in the state.

PER CAPITA PERSONAL INCOME

In 2003 Tishomingo had a per capita personal income (PCPI) of \$18,915. This PCPI ranked 58th in the state and was 82 percent of the state average, \$23,129, and 60 percent of the national average, \$31,530. The 2003 PCPI reflected a decrease of 0.6 percent from 2002. The 2002-2003 state change was 3.3 percent and the national change was 2.2 percent. In 1993 the PCPI of Tishomingo was \$13,545 and ranked 42nd in the state. The 1993-2003 average annual growth rate of PCPI was 3.4 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Tishomingo had a total personal income (TPI) of \$356,788*. This TPI ranked 52nd in the state and accounted for 0.5 percent of the state total. In 1993 the TPI of Tishomingo was \$248,895* and ranked 49th in the state. The 2003 TPI reflected a decrease of 1.4 percent from 2002. The 2002-2003 state change was 3.6 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 3.7 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Tishomingo. In 2003 net earnings accounted for 52.7 percent of TPI (compared with 59.3 in 1993); dividends, interest, and rent were 14.9 percent (compared with 16.0 in 1993); and personal current transfer receipts were 32.4 percent (compared with 24.8 in 1993). From 2002 to 2003 net earnings decreased 0.7 percent; dividends, interest, and rent decreased 12.3 percent; and personal current transfer receipts increased 3.4 percent. From 1993 to 2003 net earnings increased on average 2.5 percent each year; dividends, interest, and rent increased on average 2.9 percent; and personal current transfer receipts increased on average 6.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Tishomingo decreased from \$204,599* in 2002 to \$195,227* in 2003, a decrease of 4.6 percent. The 2002-2003 state change was 5.6 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$189,052* to the 2003 estimate was 0.3 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.3 percent.
